I understand these risks are entirely my responsibility. I expressly assume these risks. I am aware of the risks and hazards inherent upon entering the pool area and I choose to voluntarily enter the premises, knowing the conditions might become more hazardous and/or dangerous for myself and/or dog(s) and I voluntarily assume all such risks, loss, damages, or injury that may be sustained by entering the pool.

By signing this release of liability and using the pool, I hereby fully and forever release, indemnify, and discharge the Village of Plain City, Village of Plain City Aquatic Center, and their volunteers, vendors, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my use or intended use of the pool.

I fully and forever release and discharge the Village of Plain City, Village of Plain City Aquatic Center, and their volunteers, vendors, employees and agents from any and all negligent acts and omissions in the same.
