

Ordinance No. 8-2021

AN ORDINANCE AMENDING THE VILLAGE OF PLAIN CITY CODIFIED ORDINANCE CHAPTER 123 TO UPDATE THE CODIFIED ORDINANCE AND RESOLUTION PRACTICES AND PROCEDURES PURSUANT TO THE MUNICIPAL CHARTER PASSAGE.

WHEREAS, The electors of the Village of Plain City adopted the *Charter of Plain City, Ohio* at a Special Election on March 9, 2021; and

WHEREAS, “CHAPTER 123 Ordinances and Resolutions” of the *Codified Ordinances of Plain City, Ohio* is not currently compliant with the *Charter of Plain City, Ohio*; and

WHEREAS, The Council of the Village of Plain City desires to enact legislation to amend “CHAPTER 123 Ordinances and Resolutions” of the *Codified Ordinances of Plain City, Ohio* to bring it into compliance with the *Charter of Plain City, Ohio*; now, therefore, be it

ORDAINED by the Council of the Village of Plain City,

1. That CHAPTER 123 Section 123.01 POSTING OF ORDINANCES, RESOLUTIONS AND NOTICES is repealed.

3. That all prior legislation, or any part thereof, which is inconsistent with this Ordinance is hereby repealed as to the inconsistent parts thereto.
4. That this Ordinance shall take effect on July 1, 2021.

That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.
