RESOLUTION NO. 24-2021

**A RESOLUTION AMENDING THE EMPLOYMENT AGREEMENT FOR THE VILLAGE ADMINISTRATOR, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Plain City Council adopted Resolution 35-18 on August 27, 2018, appointing Nathan E. Cahall to the position of Village Administrator and approving an employment agreement between the parties, and

**WHEREAS**, the voters of the Village of Plain City approved the adoption of a municipal charter that, amongst other things, reorganized the structure of local government pertaining to the role, powers, duties, authority, and responsibilities of the Employee's position; and

**WHEREAS**, it the Parties desire to amend the previous employment agreement to properly reflect the organizational changes resulting from the charter's passage and to make other considerations; and

**WHEREAS**, the Village Council and Mr. Cahall are in agreement to amend the previous employment agreement for the position of Village Administrator.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

**Section 1.** The Village Council hereby approves the amendment to the Village Administrator's employment agreement with the Village of Plain City as detailed in Exhibit A attached hereto and incorporated herein.

**Section 2:** Village Council hereby authorizes and directs the Council President and Village Solicitor to execute said amendment which shall take effect July 1, 2021.

**Section 3:** This Resolution shall take effect at the earliest time allowed by law.
