

**Ordinance No. 11-19**

**AN ORDINANCE ACCEPTING PUBLIC IMPROVEMENTS CONSTRUCTED FOR DARBY FIELDS, SECTIONS ONE AND TWO.**

**WHEREAS**, The Village of Plain City's Subdivision Regulations under Chapter 1125 require the installation of certain public improvements for all subdivisions within the Village; and

**WHEREAS**, the developer of Sections One and Two of the Darby Fields Subdivision has installed such required public improvements in accordance with the record plans and accompanying public improvement plans previously approved by Village Council; and

**WHEREAS**, Village staff have inspected said public improvements and have found them to be installed in accordance with all applicable construction regulations and requirements of the Village; and

**WHEREAS**, the developer of Sections One and Two of the Darby Fields Subdivision desires to dedicate said public improvements to the Village and to the benefit of the public for the future.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

**Section 1.** Village Council hereby accepts the dedication of the public improvements for Sections One and Two of the Darby Fields Subdivision upon receipt by the Village of a two-year maintenance bond in the amount of \$190,118.52 in a form determined to be acceptable to the Village by the Village Administrator, all in accordance with Chapter 1129 of the Village of Plain City Subdivision Regulations. Upon receipt of said maintenance bond, the Village shall release the performance bond previously provided by the developer of Sections One and Two of the Darby Fields Subdivision.

**Section 2.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

**Section 3.** This Ordinance shall take effect at the earliest time allowed by law.
