Ordinance No. 22-22

AN ORDINANCE AUTHORIZING THE COMMENCEMENT OF PROCEEDINGS TO CREATE A REGIONAL WATER AND SEWER DISTRICT PURSUANT TO OHIO REVISED CODE CHAPTER 6119 AND DECLARING SUCH ACTION AN EMERGENCY.

WHEREAS, the Village of Plain City ("Plain City") owns and operates a potable water and sanitary sewer system within and without its municipal corporation; and,

WHEREAS, Council has determined that it will, together with the Madison County Board of Commissioners, form a regional water and sewer district pursuant to Chapter 6119 of the Ohio Revised Code;

WHEREAS, following a jointly held public meeting with the Madison County Board of County Commissioners as required by Ohio Revised Code Section 6119.02(B), Council approves the filing of a petition to form the regional water and sewer district.

NOW, THEREFORE BE IT ORDAINED by the Council of the Village of Plain City, Ohio, as follows:

1. That the Council has held a joint public meeting with Board of County Commissioners of Madison County, as required by R.C. § 6119.02(B), pursuant to notice, for the purpose of receiving comments on the proposed establishment of the regional water and sewer district and presenting the preliminary study of the reasons for the proposed establishment of the district.
2. That the Council, pursuant to the power vested in it under the laws of the State of Ohio, and more specifically, under R.C. § 6119.02, hereby finds it to be necessary and advisable, and in the best interests of the residents, to commence proceedings to create a regional water and sewer district under R.C. Chapter 6119, and by this Ordinance approves action to establish such a district and further approves the Petition and the filing thereof in the Courts of Common Pleas of Madison county, Ohio, to accomplish the same.
3. That the Council, having found the provision of water and sewer services by a regional district to be for the best interests of Plain City and its residents, authorizes all other and further action necessary and proper to implement this Ordinance so as to promote the general health, safety and welfare of said residents of Plain City.
4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees resulting in such formal action, were in meetings open to the public, in compliance with the law, including Section 121.22 of the Revised Code of Ohio.

5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the Village, wherefore this Ordinance shall be in full force and effect immediately upon its passage.
