

RESOLUTION NO. 23-2021

**A RESOLUTION AMENDING RESOLUTION 05-2021 AUTHORIZING THE SALE OF IMPOUNDED VEHICLES**

**WHEREAS**, Ohio Revised Code Section 4513.61 authorizes the Chief of Police to come into possession of vehicles as a result of the performance of the Police Department's official duties and to impound the same; and,

**WHEREAS**, On March 22, 2021, the Village of Plain City authorized Resolution 05-2021 to sell certain vehicles located in the Village's police department impound lot; and,

**WHEREAS**, Resolution 05-2021 authorized the sale of five vehicles at a public auction; and

**WHEREAS**, the Chief of Police has identified the following vehicle that has been impounded by the Village Police Department in the course of the Department's official duties and seeks to amend Resolution 05-2021 to allow the Village to retain said vehicle:

- 2009 Chevrolet Malibu (VIN: 1G1ZJ577X9F253740)

**WHEREAS**, the Chief of Police has provided notice to owners of the above vehicle to reclaim such vehicle and the same have gone unclaimed and the Chief of Police has obtained a valid title to this vehicle; and

**WHEREAS**, the Village Council wishes to amend Resolution 05-2021, allowing the Village to retain this vehicle.

**NOW THEREFORE BE IT RESOLVED** by the Village Council of Plain City, Ohio, as follows

**Section 1.** The Village Council of Plain City hereby amends Resolution 05-2021 to authorize the Village to retain the following vehicle:

- 2009 Chevrolet Malibu (VIN: 1G1ZJ577X9F253740)

**Section 2.** The Village Council hereby directs the Chief of Police to retain the identified vehicle, previously approved to be sold via public auction.

**Section 3.** This Resolution shall be effective from and after the earliest period provided by law.
