

AN ORDINANCE AMENDING THE VILLAGE OF PLAIN CITY CODIFIED ORDINANCE CHAPTER 121 ESTABLISHING COUNCIL MEETINGS PLACE AND TIME AND NOTICE OF MEETINGS PURSUANT TO THE MUNICIPAL CHARTER PASSAGE

WHEREAS, The electors of the Village of Plain City adopted the *Charter of Plain City, Ohio* at a Special Election on March 9, 2021; and

WHEREAS, "CHAPTER 121 Council" of the *Codified Ordinances of Plain City, Ohio* is not currently compliant with the *Charter of Plain City, Ohio*; and

WHEREAS, The Council of the Village of Plain City desires to enact legislation to amend "CHAPTER 121 Council" of the *Codified Ordinances of Plain City, Ohio* to bring it into compliance with the *Charter of Plain City, Ohio*; now, therefore, be it

RESOLVED by the Council of the Village of Plain City,

1. That CHAPTER 121 Section 121.01 is repealed.
2. That CHAPTER 121 Section 121.02 is repealed.
3. That the list of CROSS REFERENCES in "CHAPTER 121" of the *Codified Ordinances of Plain City, Ohio* be replaced in its entirety by the following list of new cross references:

4. That all prior legislation, or any part thereof, which is inconsistent with this Ordinance is hereby repealed as to the inconsistent parts thereto.
5. That this Ordinance shall take effect on July 1, 2021.
6. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.
