Ordinance No. 06-2021

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE AND ACCEPT BIDS FOR THE VILLAGE OF PLAIN CITY COMMUNITY-WIDE REPAVING PROJECT.**

**WHEREAS**, Village Council has adopted the 2021 Village of Plain City operating budget and capital improvement plan; and

**WHEREAS**, the community-wide repaving project is included in the 2021 budget: and

**WHEREAS**, Ohio Revised Code Section 735.05 requires Village Council to adopt an ordinance authorizing the village administrator to advertise and accept bids for said project; and

**WHEREAS**, Village Council wishes to commence the public bidding process for said project.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

**Section 1.** The Village Administrator is hereby authorized and directed to advertise and accept bids for the Village of Plain City Community-Wide Repaving Project pursuant to Ohio Revised Code Section 735.05.

**Section 2.** Upon receiving and opening bids for said project, the Village Administrator shall present a recommendation as to whether to award a contract in connection with the public bidding process. Award of a contract for the project shall be authorized by action of Village Council in accordance with the Ohio Revised Code.

**Section 3. Effective Date.** This ordinance shall be in full force and effect from and after the earliest period provided by law.
